Dear Alan,

Thank you for your letter with regard to the injury to Evan Duff which we received on August 2nd 1990. I apologize for the delay in replying but after consideration by the Committee at our August meeting, I had to discuss the matter with David Stark, who was away on holiday for a fortnight, followed by my absence interstate for a week.

The Committee is very concerned with the safety of all players and sincerely regret the injury to Evan on April 18th 1990. We wish that the incident had been brought to our attention much sooner and wonder why there should have been such a considerable delay?

In my interview with David Stark, he admitted being involved in a collision with Evan Duff but denies the "deliberate and intentional use of the forearm and elbow" injury. The videotape has been viewed exhaustively using a freeze frame video player in an attempt to establish the facts of the collision. The tape clearly shows a tap penalty set up involving a wall of players with two runners approaching the wall from the rear. Evan appears on a dummy run on the openside of the wall (the ball is moved towards the blind side) and shortly afterwards collides with a Collegians player travelling quickly towards the wall and both fall to the ground. Although the collision is very unclear, using the freeze frame facility, it is possible to see that the Collegians player passes to the left of Evan. There is a flash of white which appears to be the left forearm of David Stark at head height. However, as Evan passed on the right hand side of David Stark, the left arm could not have been involved in making contact with his face. The tape therefore does not provide evidence of accidental or deliberate contact to the head and we suggest that it cannot be used as evidence. The referee appears to be in an ideal position and the collision occurs directly in front of him although it is obvious that he is watching the ball.

Evan and David appear to be similar players in that they are prepared to give and ask no quarter. David said that he ran towards the wall and Evan appeared around the side and ran straight at him. He admitted making no attempt to avoid the collision as he was sure Evan had no intention of doing so. The speed at which they were both running also suggests it would have been very difficult for them to avoid contact.

In the past, and quite recently, a number of our players have received serious injuries as a result of illegal play. The Committee of this Club abhors foul play of all types and are prepared to take action against all players, including our own, in order to clean up the game and protect all players. However, the evidence of such foul play has to be clear and unequivocal and I am afraid that your video tape does not provide such evidence or even suggest that the injury could have been deliberate.

From the nature of your letter to the South Australian Rugby Union, I feel that this reply will be unsatisfactory to you. In the interest of future relations between our Clubs, I would be happy to meet with you to discuss the matter further if you think this would be worthwhile.



Thank you for your letter with regard to player safety and first aid facilities at the Club.

Let me first assure you that the welfare and safety of our players has the highest priority. Let me outline some of the measures taken by the Club in the area of safety and first aid.

- 1. We have taken out accident insurance as part of a compulsory scheme run by the Australian Rugby Union. Details of this scheme are on the notice board, but in brief, it covers players against serious injuries such as paraplegia, loss of limbs or sight etc. This scheme provides cover for up to \$250,000 and costs us \$2,150 per year or a premium of \$240 per team.
- 2. Next season it will be possible for this scheme to be extended to cover loss of wages at an additional cost of \$200 per team.
- 3. All teams are provided with comprehensive first aid kits at the start of the season to cover minor injuries which commonly occur in the game. We maintain s store of replacement items so that team managers should always have a complete kit throughout the season. This first aid equipment has cost the Club almost \$1,000 this season.
- 4. Items to cover more substantial injuries include a Jordan Frame, a variety of inflatable splints and a number of heat/cold packs for soft tissue injuries.
- 5. The recent donation of \$500 by New Spot Motors has been used to purchase a new general purpose stretcher which will be stored in the changing rooms (with the Jordan Frame), additional inflatable splints and heat/cold packs, and a general first aid kit to be kept in the Clubrooms for use by non-playing members.
- 6. Now one in the Club has first aid/sports injury qualifications. We encourage such qualifications and are prepared to pay for attendance at courses. However, if we were to insist on this as a prerequisite for team managers then I am sure we would not have any.

7. If we have any serious injuries on the field in my experience the Club has always called an ambulance - for which we pay if the member is not covered - or arrange to take the injured to hospital for treatment.

I hope this letter assures you that we have taken sensible and responsible precautions with regard to the safety of playing members. It is a real shortcoming that we do not have trained personnel in attendance at <u>all</u> matches and I am sure that the Committee would welcome all help or suggestions to overcome this problem.
